The applicant is requesting approval of a withdrawal of 0.14 MGD (97 gpm). However, a withdrawal rate of only 70 gpm (0.10 MGD) could be sustained during the 72-hour pump test. Even at this lower rate, several significant water-bearing zones were partially dewatered during the test. Therefore, staff recommends approval of 0.1 MGD (the test rate). Applicant shall comply with water conservation requirements as per Section 803.63 and reporting requirements as per Section 803.62 of the SRBC Project Review Regulations. Commission will review conservation measures to assess their effectiveness in mitigating consumptive losses.

Applicant did not measure water levels in nearby wells during pumping test. However, total withdrawal was only 54 feet at a pumping rate of 1,650 gpm after 120 hours. The applicant is requesting approval to withdraw about 430 gpm which should result in a significantly smaller drawdown and limited impact. Applicant shall comply with water conservation requirements as per Section 803.63 and reporting requirements as per Section 803.62 of the SRBC Project Review Regulations. Commission will review conservation measures to assess their effectiveness in mitigating consumptive losses.

The pumping test submitted with the application does not comply with SRBC Regulations (e.g. water level measured to within 0.1 ft., constant pumping rate, and at least one observation well). However, because the requested withdrawal is about half the test rate and there do not appear to be any other water sources significantly impacted, staff recommends approval of the project. Applicant shall comply with water conservation requirements as per Section 803.63 and reporting requirements as per Section 803.62 of the SRBC Project Review Regulations. Commission will review conservation measures to assess their effectiveness in mitigating consumptive losses.

Project was originally approved by the Commission on 3/12/87. The applicant submitted a letter dated 2/23/88 requesting that they be allowed to file their report on consumptive use make-up as late as 9/12/88. Applicant is also planning to drill a fourth well, since pumpage from two of the original wells directly affects each other. Applicant plans on using some water for testing purposes beginning in May 1988. Consumption is scheduled to begin in late summer or early fall of 1988. Commission staff recommends granting an extension of the due date for the applicant's consumptive use make-up report effective from 3/12/88 through 9/12/88. All other conditions of the Commission's 3/12/87 interim approval remain in full force and effect. Applicant must submit a complete application with supporting data for the fourth well, if it is to be developed.

## Pa. Independent Regulatory Review Commission

Pa. Environmental Quality Board 19880413

Proposed changes of designated uses for selected streams in the Susquehanna River Basin. The proposed amendments, if adopted, will establish more restrictive uses than those currently designated for Bennett Branch, Sinnemahoning Creek, Cameron County, and less restrictive uses for the South Branch Wyalusing Creek, Susquehanna County; Leggetts Creek, Lackawanna County; Toby Creek, Luzerne County; Buffalo Creek, Union County; and Little Muddy Creek, Lancaster County. Staff supports the proposed regulations.

The streams being downgraded are being recovered from coldwater uses to warmwater uses.
